Since 1906, the Lighthouse has been creating independent living opportunities throughout the Chicago area for people who are blind, visually impaired, or blind with additional disabilities.

## THE CHICAGO LIGHTHOUSE EXHIBITION GENERAL CONDITIONS OF ENTRY

1. The exhibition is open to anyone; however, an entry may be rejected when the sponsoring organization or its agent, in its reasonable discretion, believes the entry does not conform to the exhibition rules and conditions. No entry will be judged or returned until moneys for entry fee has been received.
2. An entrant may enter up to all three categories.
3. All possible care will be exercised in the handling and exhibition of entries but no responsibility is assumed for loss or damage.
4. An entrant's four, or fewer, images will be distributed throughout four rounds of judging in whichever section they are entered. The "in-out" elimination method of scoring will be used to select acceptances until 35-45% of the entries are kept.
5. North American entries will be returned by first class mail and all others by Small Packet Air. If requested, entries will be forwarded to another North American exhibition.
6. An image may only be entered in one category. If an image is entered as both a slide and a print, only the slide will be judged. If an image is entered as both a stereo print and an anaglyph print, only the stereo print will be judged.
7. An image in a specific format accepted in a previous Lighthouse Exhibition is not eligible for entry in this exhibition, no matter what the title, however, previously accepted slides may be entered in either print category, and previously accepted prints may be entered as slides.
8. Entries must originate as photographs (image-captures of objects via light sensitivity) made by the entrant on photographic emulsion or acquired digitally. By virtue of submitting an entry, the entrant certifies the work as his own and permits the sponsors to reproduce all or part of the entered material free of charge for publication and/or display in media related to the exhibition. This may include low resolution posting on a website. The exhibition assumes no liability of any misuse of copyright. Images may be altered, either electronically or otherwise, by the maker and artwork or computer graphics created by the entrant may be incorporated if the photographic content predominates subject to divisional restrictions. All final work must be on photographic film (slides), or on photographic or electronic print material (Holmes-style prints and anaglyphs), mounting excepted.

### CONDITIONS OF ENTRY – SLIDES

1. A maximum of four slides of the entrant's own making may be submitted.
2. Each slide must be labeled with the title and the maker's name and address. Slides shall be spotted in the lower left corner as viewed in a hand viewer. Slide and entry form numbering should match.
3. Slide thickness must not exceed 1/8-inch.
4. Mounts shall be American standard 1 5/8 " X 4" and may be cardboard, glass or plastic. Chip sizes up to and including seven sprockets are eligible.
5. Judging will be by projection on a 70" silver lenticular screen using 750W lamps.
6. Awards will be chosen either by the "in-out" method or through discussion, as determined by the judges.

### CONDITIONS OF ENTRY – STERO CARD PRINTS

1. A maximum of four stereo prints may be submitted, 7-inch wide print viewable in a Holmes-style viewer.
2. Stereo prints should show the title with maker's name and address on the back of the print. Print and entry form numbering should match. The makers name on the face of the print will be covered.
3. Awards will be chosen from a simultaneous display of all accepted prints.

### CONDITIONS OF ENTRY – ANAGLYPH PRINTS

1. A maximum of four RED-CYAN anaglyph prints may be submitted, 8.5X11 inch maximum size.
2. Stereo prints should show the title with maker's name and address on the back of the print. Print and entry form numbering should match. The makers name on the face of the print will be covered.
3. Awards will be chosen from a simultaneous display of all accepted prints.
